- 1950** Yamani Seisakusho Ltd. was renamed Yamani, Inc.  
Established Head Office at Niban-cho, Taito-ku, Tokyo
- 1960** Constructed headquarter building at Misuji, Taito-ku, Tokyo
- 1966** Contracted Technical Assistance License Agreement with Hickok (U.S.A)  
Established Hickok Japan, Ltd.
- 1969** Established wholly owned subsidiary, Yamani Manufacturing Co., Inc.  
(now Monoro Inc.), at Kinshi-cho, Sumida-ku, Tokyo
- 1974** Constructed new headquarter building at Misuji, Taito-ku, Tokyo
- 1976** Established Osaka Business Office (now Osaka Branch)
- 1980** Increased the capital to 90,000,000 Yen  
Constructed Apparel Belts Manufacturing Factory at Kamisato-cho,  
Kodama-gun, Saitama Prefecture
- 1983** Commenced a handbag business
